

## The Scioto Valley REALTORS® Scholarship Application Criteria and Application Process

- 1. Applicants shall have a GPA of 2.5 or greater.
- 2. Applicants shall submit a High School Transcript with their application.
- 3. Applicants shall submit one letter of recommendation from a teacher, coach, or community leader.
- 4. Applicants must be accepted in a full-time status at an accredited or qualified post-secondary educational institution and shall provide an acceptance letter.
- 5. All Scholarships will be paid directly to the post-secondary institution.
- 6. Applicants shall complete application form as well as the essay questions.
- 7. If chosen to move to the second step, applicant will be required to do an interview with the committee.
